Old Business

LI ABATE Truck: The LI ABATE truck is running well. It was recently painted by **New Tech Auto Collision** for \$2500. Thank you to **Concourse Auto Body** for the donation of \$250 to put toward the cost of painting and repairs.

NYS Governor's Traffic Safety Committee Grant: 2019 New York State Governor's Traffic and Safety Board Grant: LI ABATE was approved for \$31,000 for 2019 for educational and awareness materials to emphasize motorcycle awareness to the public sector. Materials approved include a *GoPro* to produce PSAs and a laptop, projector and screen to do safety and awareness training. We were also approved for materials to make additional highway signs.

LI ABATE Highway Signs: While we were approved in the 2019 NYSGTS Grant to produce additional highway signs, posting them is difficult, as Suffolk County is no longer permitting signs on county roadways, nor can signs be posted in the Town of Islip. Brookhaven Town, in conjunction with LI ABATE will continue to post highway signs as will Babylon Town. If anyone knows of visible private property where signs can be posted, this is also an option.

New Business

LI ABATE Lottery: LI ABATE will be fundraising through a 6month daily drawing, based on NYS evening daily numbers. The lottery will run from July 1, 2019 through December 31, 2019. Tickets are \$20 each. We can sell up to 1,000 tickets.

Grant Money: LI ABATE would like to seek additional grant funding to assist us in providing

LI ABATE Headquarters: LI ABATE is looking for headquarters large enough to hold our monthly meetings as well as to open an educational and training center. A building in Centereach, on Middle Country Road, became available. Jim and Nick spoke to the landlord about leasing the building and explaining what LI ABATE wanted to accomplish. Jim will further research the feasibility of renting this space, including meeting with the fire marshal and local elected officials.

LI ABATE Lifetime Memberships: Annual membership to LI ABATE is \$20.
