Did you know that it cost 3.69 cents to make one penny? The very last penny was made at the U.S. Mint in Philadelphia on November 12, 2025. President Donald Trump ordered the cease of production as a budget cutting measure.

The penny, also known as the U.S. one-cent coin, takes its name from the British penny which was widely used during the colonial period. The first U.S. cent was produced in 1787. On April 2, 1792, Congress passed the Coinage Act, establishing the first national mint in the United States. 100% Copper was then used from 1793 to 1857.

The penny went through some face lifts, and some are worth way more than 3.69 cents now.

As Jan said in Grease "See a penny pick it up, all day long you'll have good luck" Maybe you will be lucky, (unlike Kenickie who hit his head and couldn't drive Grease Lighting) and find a rare old penny in a piggy bank that you've had sitting around collecting dust.

I was also very proud to speak on our participation in attending the High School Driver Education classes! LI ABATE under the leadership of our President Chris Beckhans, who sets up scheduling for all school districts in both counties that participate. The teachers are our members who are trained to deliver the one-hour course! Just an incredible service we provide!

Lastly, I attended the Newsday forum about "Dangerous Roads" a few weeks ago. Maybe you saw the article in Newsday? For those who didn't, it was about all the things we see as motorcyclists every time we are riding! Cars weaving in and out changing lanes on the Expressway without signaling and driving at an excessive speed, cutting us and cars off, verbal abusive language and hand gestures etc. Discussion also from the audience went from timing of crosswalk signals to traffic light timing of red, yellow and green. I hope you had time to read the article in Newsday.

Greetings ABATE Members,

There are many changes coming our way this year, so let's start with the New York Traffic Laws and Point system. This information comes directly from the DOT:

New York's major traffic law changes for 2026 focus on a stricter point system (effective February 2026), increasing points for speeding, phone use, and school bus violations, extending point duration, and lowering the threshold for license suspension; plus, NYC is adding more red light cameras, and the "Move Over Law" has been expanded, all aimed at boosting road safety.

Key Traffic Law Changes (Effective February 2026)

- **Stricter Point System:** Points stay on your license longer (24 months instead of 18), and the threshold for suspension drops from 11 points to 10 points within that 2-year period.
- **Increased Points for Violations:**
 - Speeding (up to 10 mph over): 4 points (up from 3).
 - Cell Phone Use: 6 points (up from 5).
 - Reckless Driving: 8 points (up from 5).
 - Passing Stopped School Bus: 8 points (up from previous).
 - New Violations Added: Broken taillights/headlights (1 point each), illegal U-turns (2 points), failure to move for emergency vehicles (3 points).
- **Enhanced "Move Over Law":** Now covers hazard vehicles, responder vehicles, and all stopped vehicles on the roadway.

Other Notable 2026 Developments

- **More Red Light Cameras:** New York City plans to have cameras at 600 dangerous intersections by 2026 to deter red-light running.
- **Increased Enforcement:** Expect heightened patrols for DWI, speeding, distracted driving, and Move Over Law violations during campaigns like the holiday season.

These changes aim to deter risky driving and significantly improve road safety across New York State by making penalties harsher and longer lasting for infractions.

New Point-Carrying Violations: prior the following didn't have points now they do;

- **Equipment Issues:** Broken headlights/taillights (1 point).

- **Illegal U-Turns**: 2 points.
- **Obstructing Traffic**: 2 points.
- **Failure to Move Over for Emergency Vehicles**: 3 points.
- **Aggravated Unlicensed Operation (AOU)**: 11 points
- **Speed Contests or Races**: 5 points

Now we also have two important bills with the **House Energy and Commerce Subcommittee on Commerce** so watch for the **Calls to Action** to support these important bills for the Motorcycle community:

- HR 3385 – Federal definition of a Motorcycle
- HR 1566 – The Repair Act

There are 16 other bills pending and as they show concern for the community, we will be putting them out there.

Ride safe and keep in the know.

MRF Priorities Center Stage

Just two weeks into 2026, the Motorcycle Riders Foundation (MRF) is already seeing key priorities move into the spotlight on Capitol Hill. On Tuesday, the House Energy and Commerce Subcommittee on Commerce, Manufacturing and Trade will hold a hearing titled "American Automotive Safety, Affordability, and Leadership." This is a critically important venue for addressing issues that impact motorcyclists, as it brings together lawmakers who shape federal policy on vehicle standards, consumer protections, and emerging transportation technologies.

Sixteen bills are listed for possible discussion during the hearing. While it is unlikely that each proposal will receive the in-depth attention it deserves, the sheer number of measures under consideration signals that this powerful committee is paying close attention to the future of American mobility. Of particular interest to riders is H.R. 3385, legislation to update the federal definition of a motorcycle, along with H.R. 1566, the REPAIR Act, which focuses on the right of consumers to repair and modify their vehicles. Also included are informal legislative drafts addressing autonomous vehicle policy, an area the MRF continues to monitor closely as these technologies increasingly share the road with motorcyclists.

The MRF has been in active contact with our champions on Capitol Hill, as well as congressional committee staff, regarding the hearing and the bills under review. These conversations are essential to ensure the unique needs and safety concerns of America's motorcyclists are understood as lawmakers debate affordability, safety, and innovation in the automotive space.

The message is clear: even at the very start of the year, MRF priorities are at the forefront in the halls of Congress. We will closely track the hearing and keep our members informed about the discussions, outcomes, and next steps as they unfold.

Congressional Committee Discusses Key Biker Issues

Earlier this week, the House Energy and Commerce Committee's Subcommittee on Commerce, Manufacturing, and Trade convened a hearing focused on America's automotive future, including the deployment of autonomous vehicles, the federal definition of a motorcycle, and pending right to repair legislation.

A major theme of the hearing was the urgent need for clear, consistent national standards for autonomous vehicle technology. Committee Chairman Brett Guthrie of Kentucky emphasized the importance of federal leadership, stating, *"We need a national standard that is robust, safe and gives people assurances on the technology. We cannot have 50 different patchwork standards."* This concern mirrors long-standing warnings from the Motorcycle Riders Foundation (MRF) that motorcyclists cannot be an afterthought in the design and regulation of emerging vehicle technologies.

The hearing also addressed the outdated federal definition of a motorcycle, particularly as new vehicle types such as autocycles enter the marketplace. The MRF, joined by ABATE of Wisconsin, submitted letters for the record in support of modernizing the federal definition and urging passage of H.R. 3385, legislation intended to ensure that motorcycles are accurately defined and treated consistently across all states.

Right to repair legislation was another focal point, with discussion of the REPAIR Act, H.R. 1566. Bill Hanvey, President and CEO of the Auto Care Association, testified in strong support of the bill, saying, *"The REPAIR Act simply allows the consumer to be able to choose where, when and how their vehicle is repaired."* Hanvey also noted that more than 235,000 independent repair shops operate nationwide, providing consumers with reliable and affordable repair options that are increasingly threatened by restricted access to vehicle data and tools. The MRF supports the REPAIR Act and believes that the right to modify is also a key part of this discussion.

The MRF remains committed to ensuring that federal lawmakers understand the unique needs of motorcyclists, whether that means being properly recognized in vehicle definitions, accounted for in the deployment of autonomous technology, or empowered to maintain, repair and modify their own machines. This week's hearing demonstrated growing momentum in Congress to address these critical issues.

Motorcycle Riders Foundation 2026 Legislative Priorities

2026 HIGH PRIORITY OBJECTIVES

Autonomous Vehicles:

Advocate and monitor any legislation or regulations related to motorcycles concerning connected and autonomous vehicles (AV):

- Endorse rulemaking to set new standards specific to seeing, detecting, and properly reacting to motorcycles.
- Ensure motorcycles are part of all testing and development procedures.
- Promote that any AV public user advisory committees should include a representative from the motorcycle community and a motorcycle manufacturer.
- Require a public, easily accessible, and searchable database where consumers can look up important safety information such as the limitations and capabilities of different products offered by AV manufacturers or service providers.
- Require that all AV manufacturers must submit safety evaluation reports to detail and make public how their vehicles identify motorcycles among other road users. Manufacturers must also include human error analysis in safety reports.
- Require that all AV manufacturers publicly report crash data and share incidents between AVs and motorcycles just as they would incidents between AVs and other road users.
- Protect the safety of motorcyclists with any rules or standards as they relate to electronic and cybersecurity systems including the clarification of rights of data ownership of any recorded data in the context of connected and autonomous vehicles.
- Inclusion of motorcyclists' perspectives in discussions regarding the Intelligent Transportation System (ITS).
- Work to ensure motorcycles are a separate classification of vehicle and road user for purposes of regulation and testing of AVs.
- Protect the set aside radio spectrums necessary for Dedicated Short Range (DSRC) vehicle to vehicle communications.
- Protect additional spectrum as needed for Vehicle to Everything technology (V2X).

Crash Avoidance:

Continue to promote the theme of crash avoidance versus safer crashing urging the National Highway Traffic Safety Administration (NHTSA) and the U.S. Department of Transportation (DOT) to focus on crash prevention and support rider education by providing funding and other resources.

Data Recording:

Pursue legislative language that any collected or available vehicle data is the property of the consumer.

The consumer should have the choice of whether to opt-in to having their personal data communicated to interested parties.

Definition of a Motorcycle:

Educate policymakers and ask for a change to the current definition that better reflects the current two and three-wheel motorcycle landscape. Collaborate with appropriate stakeholders concerning the federal definition of a motorcycle, ensuring that crash and fatality statistics continue to be separate from other classes of vehicles including autocycles, non-motorcycle powered vehicles such as mopeds, scooters, motorized bicycles, and various cabin-based steering wheel type vehicles.

Emission Regulations:

- Engage the Environmental Protection Agency (EPA) & Congress on any activity related to motorcycle emission regulations.
- Work against any efforts by the California Air Resources Board (CARB) or any other agencies or boards that endanger the future of motorcycling.

Helmet Laws/Equipment Mandates:

Oppose any mandatory federal helmet or personal protective equipment/apparel mandates. Advocate for limiting funding of any federal government entity with increasing involvement in advocating for a universal helmet law or similar initiatives.

Internal Combustion Engines:

Work to ensure the survival of internal combustion engines, including elimination of the California air quality exemption waivers which allows California to enact different standards and threatens internal combustion engine production. Pursue similar policies for other state or federal agencies or boards as needed.

Profiling:

Sustain lobbying efforts for the passage of resolutions or legislation that promote awareness related to, and prohibit the practice of, the profiling of motorcyclists. Seek opportunities to include legislative language that:

- Monitors and responds to federal legislative or regulatory activity concerning the usage of the terms gang, club, or any derogatory term when referring to motorcyclists.
- Promotes increased public awareness on the issue of profiling of motorcyclists. Encourages collaboration and communication with the motorcycling community and law enforcement to engage in efforts to end profiling of motorcyclists.
- Urges state law enforcement officials to include statements condemning profiling of motorcyclists in written policies and training materials.
- Outlaws the practice of profiling of motorcyclists.

- Opposes any motorcycling, motorcycle, or motorcyclist-based discriminatory legislation or rules proposed by the U.S. Congress or by any governmental agency.
- Protects U.S. citizen motorcyclists reentering the country from undue detainment based on their associations, apparel or lifestyle.

Renewable Fuels:

Advocate for targeted changes to the Renewable Fuel Standard (RFS) including the following actions:

- Support the universal availability of approved fuel blends, containing no more than 10 percent ethanol by volume.
- Promote additional research and independent studies concerning the effects of higher blends of renewable fuels on motorcycles.
- Ensure the availability of separate pumps (i.e., no multi-dispensing, blender pumps) to minimize the risk of damage to motorcycle engines where higher blend of renewable fuel blends is available.
- Sustain lobbying efforts for the passage of legislation which requires information to be provided to the public about the risks associated with the improper use of E15 fuel (or higher) in certain vehicles, engines, and equipment.

Right to Repair/Modify:

Protect and advocate for "Right to Repair" provisions that allow consumers the ability to repair and modify their own products or allow a designee selected by the consumer to repair or modify the consumer's property.

- Promote access to parts, tools, diagnostic equipment and other technology that allows the consumer or their chosen designee the ability to repair and/or modify motorcycles.
- Advocate for the availability of reproduction parts by third party vendors, ensuring consumer choice in the selection of products.
- Monitor California Air Resource Board or any other state, agency or board's policies on parts approval process and transparency.

Surface Transportation Reauthorization (Highway Bill):

Advocate and pursue legislative efforts related to the next highway bill reauthorization (the current act is set to expire 2026). Ensure the following provisions are included:

- Promote Motorcycle Education & Awareness Program Grant Funding. (Renewed Every 5 years)
- Preserve the ban on federal funding for Motorcycle Only Checkpoints.
- Preserve the NHTSA Lobbying Ban and expand to other federal agencies.
- Reestablish the Motorcyclist Advisory Council (MAC) to advise the U.S. Department of Transportation. (Renewed Every 5 years)
- Preserve motorcycles are not considered single-occupancy vehicles for HOV lane access.

- Oppose any motorcycling related federal blackmails or federal sanctions.
- Monitor for any action that would negatively impact motorcycles, motorcycling, and motorcyclists.
- Advocate the integration of an updated federal definition of a motorcycle.
- Advocate a mandate that autonomous vehicles must detect and respond to motorcycles.
- Advocate for expanding opportunities to address motorcyclist profiling.
- Ensure motorcycles are not banned from federally funded roads.
- All high priority MRF Legislative priorities and emerging technologies

Vulnerable Roadway User Terminology:

Monitor and ensure that motorcycles and motorcyclists are a specific and unique category or classification.

2026 MEDIUM PRIORITY OBJECTIVES

Lane Filtering and/or Lane Splitting:

Monitor and support federal efforts to study and review the benefits and concerns of lane splitting and lane filtering.

Taxes:

Encourage fair treatment of motorcyclists in any change to federal taxes related to transportation. Vehicle miles traveled and other tax proposals must account for the different impact motorcycles have on infrastructure.

2026 MONITOR ITEMS

Distracted Driving:

Work to discourage any/all forms of distracted driving.

End of Life Directives:

Oppose any program that seeks to limit the like usage of motorcycles based on manufacture date.

EV Incentives:

Seek fair tax rebate and or credits for the purchase of electric motorcycles similar to those offered for electric automobiles.

Exhaust Systems:

Monitor and vigorously oppose any federal standard proposing stamping and certifying of motorcycle exhaust systems.

International Partnerships:

Continue participation in motorcycle-related activity in the European Union, United Nations, Canada, India, China and other relevant global markets informing the membership of key developments.

National Studies:

Continue monitoring any national studies concerning motorcycles (i.e., Federal Crash Causation Study or MSF Naturalistic Study).

Opponents:

Monitor private and public organizations that oppose the legislative agenda or mission of the MRF.

Sound Testing:

Monitor any SAE Motorcycle Roadside Sound Testing (addressed by individual states).

- Monitor any action by the EPA Office of Noise Abatement.

Tariffs:

Monitor any tariffs on imported motorcycles, parts, or apparel.

Tolling:

- Monitor fair tolling concepts on federally funded roadways and projects supported by federal bonds.
- Monitor any congestion tolling concerning motorcyclists by federal, state, or local governmental agencies.
- Ensure that tolling technology is safe for use by motorcyclists.

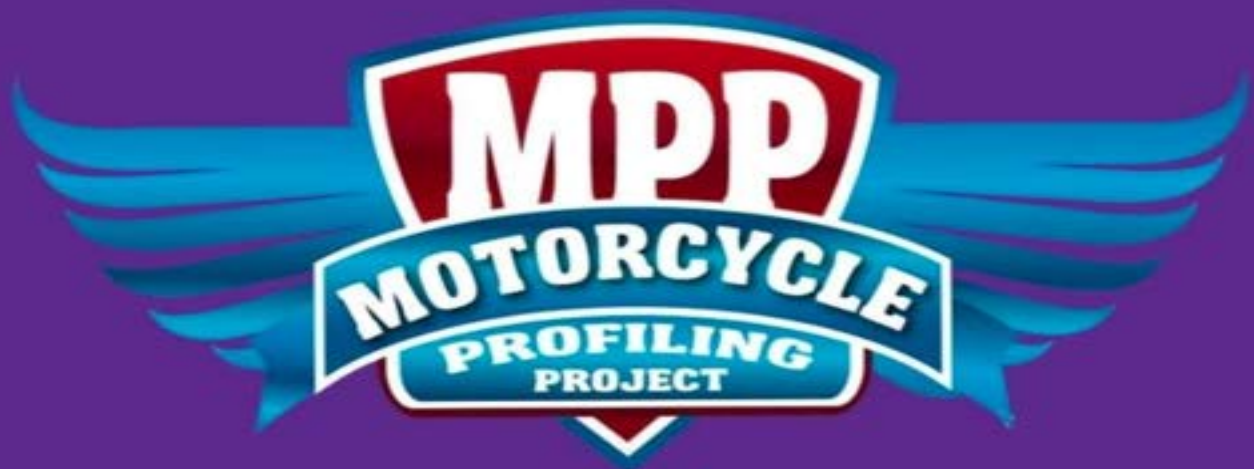

Hearing Aid Delivery Models: Understand Your Options

Hearing aids can be purchased and fit through several different models. Each option has different levels of professional involvement, technology features, and costs. Understanding these models can help you choose what best fits your needs, budget, and hearing goals.

Prescription Hearing Aids

Prescription hearing devices are professionally fit by an audiologist. They are best for individuals of any age and with **any degree** of hearing loss, or those who want full professional care. This is the best option for complex hearing losses and for those who may need additional support with technology and adapting to amplification.

An audiologist provides a hearing evaluation, recommends appropriate technology, programs the hearing aids to your unique hearing profile, and makes adjustments as needed to optimize your benefit. Ongoing professional care includes follow-up visits, hearing aid maintenance and repairs, and personalized programming adjustments as needed. Hearing care is provided in-person, with remote services also available. Prescription hearing aids offer the highest level of customization and comprehensive support for long-term success, and the cost is the highest of the three delivery models.

Over-the-Counter (OTC) Hearing Aids

OTC hearing aids are self-fitting and typically are not fit by an audiologist. They are not appropriate for all types of hearing loss or for children under 18 years of age. OTCs are best for adults (18+) with **mild to moderate** hearing loss who want a “do-it-yourself” option.

OTC devices can be purchased directly in stores or online *without* a hearing test or visit to an audiologist. The user controls setup and adjustments using a smartphone app or built-in controls. Customization is limited and may not address complex hearing needs. Individuals who are not tech-savvy or who have limited dexterity may find it difficult to manage OTC devices on their own, leading to frustration and non-compliance. OTCs are budget-friendly, with the lowest upfront costs. Returns and customer support vary by retailer.

Online Hearing Aids (Direct-to-Consumer)

Online or “direct-to-consumer” hearing aids are purchased through a company’s website. Some may include a remote hearing test or optional virtual support from hearing specialists (not always audiologists). Some remote programming adjustments or telehealth support is available; however, it may be difficult to troubleshoot problems remotely. Quality and service vary widely by company. This model of hearing aid delivery is best for adults with **mild to moderate** hearing loss who want more support than OTC options but less cost than traditional care.

Bottom Line

Audiologist-fitted hearing aids provide the most accurate, personalized, and supported approach, especially when hearing needs are more complex or communication is critical in work and social situations. OTC and online hearing aids can be a good starting point for adults with simple, mild hearing loss and comfort with self-management.
